Read the following points carefully and if you are not sure you understand, ask the Staff for an explanation.

### Restrictions and access by boat

- Particularly inexperienced customers are required to stay in the safety area, meaning the deck area as such of the boat, that is the deck where the scuba tanks are located
- Children under the age of 10 will not be able to enter the boat unless accompanied by adults who take responsibility for them.
- Entry by boat is not permitted to those with wounds, skin lesions, unless a certificate is presented doctor. Persons suffering from pathologies or conditions that involve a risk in using the boat, in excursions snorkelling, free diving and scuba diving are invited to protect their own and others' safety, to communicate to the staff on duty, before entering the water, your pathological state;
- The use of the boat and of the equipment is understood to be carried out at the risk of those who practice diving, free divers, snorkelers and their companions;
- Each customer must behave in such a way as not to compromise the safety and peace and enjoyment of the services/products by the other customers involved and must comply with the rules of normal prudence and diligence, to all the instructions given by the staff of the diving center Le Cavallette Diving snc, and/or by the operators who organize snorkelling excursions, diving with SCUBA group and freediving, as well as the regulations and provisions administrative or legislative relating to the service/product.
- The customer will be liable for all damages that the Organizer may suffer due to non-compliance with the aforementioned obligations. In particular, the customer will be liable for all damages caused to the Tresette II boat or its furnishings and equipment, damage caused to other passengers and third parties, as well as all contraventions, fines and expenses for which, due to its fact, Le Cavallette Diving is subject to port, customs and health authorities.

### It is forbidden

- running, making noise, chasing each other, causing harassment, causing situations of danger for oneself or for others;
- enter the captain's cabin;
- smoking (the prohibition applies in any area except those expressly authorized);
- dive from the upper deck, dive with a running start or dive backwards;
- get on the sundeck when the boat is moving;
- stop at the bow when the compressor is on;
- stand on the steps;
- stand on the right and left side of the cabin;
- throw waste of any kind outside the appropriate containers, much less into the sea;
- throw toilet paper and waste in general inside the toilet;
- entering the forward lower deck cabin wet;
- leave the weight box without the lid;
- sit on the support of the fin holder net;
- climb onto the roof of the captain's cabin;
- open the safety lock belt of the ladder located at the stern without authorisation;
- use the "compressor hoses to refill the cylinders" without authorisation;
- stand under the ladder located at the stern;
- leave leads on the benches;
- leave the cylinders unattended without closing the tightening belts;
- enter the water without authorization from the staff;
- dive without a signal balloon;
- stop at the bow during mooring manoeuvres;

The undersigned, by signing this declaration, declares to have understood everything written in the previous points, accepts the regulation and, before signing, declares to have read and understood all the terms of the regulation.
